Lennard W. Stillman (the “Liquidator”), Special Deputy Liquidator of Western Insurance Company, in Liquidation (“Western”), through his undersigned counsel of record and pursuant to Rule 7(d) of the Utah Rules of Civil Procedure, hereby states as follows:

1. The Liquidator filed and served his *Motion to Strike* and supporting memorandum of law and declaration on September 27, 2013 (the “Motion”).

2. The LG Warranty Claimants filed and served their Memorandum in Opposition to Liquidators Motion to Strike on September 30, 2013.

3. The Liquidator filed and served his Reply to Memorandum in Opposition to Western's Motion to Strike on September 30, 2013.

4. Although a hearing in this matter was held October 3, 2013 before Hon. John Paul Kennedy, there has been no decision on the Motion.

5. On October 24, 2013 the Court ordered the parties to mediate the disputed claims and to resubmit the Motion to Strike for Decision if that mediation was not successful.

6. On December 13, 2013 the parties mediated the matter but were unsuccessful in resolving the claims

7. Based on the foregoing, the Liquidator respectfully requests that the Court (a) consider and grant the Motion, in its discretion, without further notice or hearing, and (b) schedule a hearing on the underlying proofs of claim submitted by claimants LG Warranty Co., LLC and Immke Auto Group and the Liquidator's notices of determination regarding the same.
